## Municipal News

#### Provincial Property Tax Rebate for Seniors

This program, administered by Service Nova Scotia on behalf of the Department of Community Services, is designed to help eligible seniors remain in their homes by providing them with an annual rebate on their municipal property taxes. This program provides eligible homeowners with a 50% rebate of the actual residential municipal property taxes paid in the previous year, up to a maximum of \$800/year. To be eligible to receive this rebate you must have been receiving the Guaranteed Income Supplement (GIS) or The Allowance and you must also have your previous year's property taxes paid in full. The forms are not yet available but should be out in early July.

#### Municipal Residential Low Income Property Tax Exemption

The Municipality of the District of St. Mary's provides assistance to homeowners to help pay their residential property taxes. Qualified applicants will receive a credit which is applied directly to the tax account. To qualify you must be a Canadian citizen and permanent resident of St. Mary's Municipality. Your income must be \$21,000 or less, own the assessed property and occupy it as your home with the prior year's property taxes paid in full. #### Intent to Consider- Alternative Voting By-Law

The Municipality of the District of St. Mary's has drafted a new By-Law called the Alternative Voting By-Law. This By-Law is being considered by Council to complete the necessary requirements if Council were to choose to implement alternative methods of voting for future elections. This By-Law is a model By-Law from the Association of Municipal Administrators and was presented to Council on June 3rd, 2020 at the Committee of the Whole meeting. At this time, a resolution was made to commence with the first reading of the Bi-Law at the meeting of Council on June 8th, 2020. The second reading and motion to approve the By-Law is set for the next meeting of Council on July 13th, 2020 at 7:00pm. #### 2020 Municipal Elections

The Municipal Returning Officer has received the List of Electors from Elections NS and will be revising the list internally in order to have the Preliminary List of Electors completed by July 31st, 2020. After preparing the preliminary list there will be a least two advertisements placed in both the Municipal Newsletter and Guysborough Journal advising residents on how they can check if their name is on the preliminary list and when and where the Returning Officer will receive applications to revise the list. At the June 17<sup>th</sup> Committee of the Whole Meeting, Council made a recommendation to implement alternative voting methods for the 2020 Municipal Elections. The voting methods being considered for the election include electronic voting, telephone voting and one central polling station that will have paper ballots. The second reading of the Alternative Voting By-Law and a motion on the voting methods will be on the agenda for the July Council Meeting. Please keep an eye on the newsletter for more information on the 2020 Elections in the upcoming months.

#### Construction and Demolition Materials (C&D)

Did you know our Municipal Transfer Station accepts construction and demolition materials? If you are tearing down a building or just cleaning up old materials in the yard, some of those materials are considered C&D. Some acceptable C&D Waste examples include concrete & brick, grubbing and brush, clean soil and rock, siding, tile, Gyproc, insulation, solid roofing material and glass and vinyl window casings.
