3. Approval of Agenda

On motion of Councillor Harpell and seconded by Deputy Warden Fuller, Council approve the agenda as presented.

a. Canada Day Celebrations:

- Council discussed thoughts surrounding Municipal Canada Day celebrations. Council agreed that in light of recent discoveries it would be inappropriate at this time to use the day as a celebratory anniversary of the nation. July 1st should be encouraged as a day of reflection and a show of support of indigenous culture.

b. CAO Hiring Recommendation:
